

AN ACT

relating to the sale of certain alcoholic beverages to private club registration permit holders.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 19.01, Alcoholic Beverage Code, is amended to read as follows:

Sec. 19.01. AUTHORIZED ACTIVITIES. The holder of a wholesaler's permit may:

(1) purchase and import liquor from distillers, brewers, wineries, wine bottlers, rectifiers, and manufacturers who are holders of nonresident seller's permits or from their agents who hold manufacturer's agents permits;

(2) purchase liquor from other wholesalers in the state;

(3) sell liquor in the original containers in which it is received to retailers and wholesalers in this state authorized to sell the liquor; ~~and~~

(4) sell liquor to qualified persons outside the state; and

(5) sell ale and malt liquor to a holder of a private club registration permit.

SECTION 2. Section 20.01, Alcoholic Beverage Code, is amended to read as follows:

Sec. 20.01. AUTHORIZED ACTIVITIES. The holder of a general

19 Sec. 21.01. AUTHORIZED ACTIVITIES. The holder of a local

23 who are holders of nonresident seller's permits and from their
24 agents who are holders of manufacturer's agent permits;

27 (3) sell the malt and vinous liquors, in the original

2 wholesaler's permittees and, in his county of residence, to local
3 distributor's permittees and retailers, including mixed beverage
4 permittees and daily temporary mixed beverage permittees; and
5 (4) sell ale and malt liquor to a holder of a private
6 club registration permit.
