

SENATE CONCURRENT RESOLUTION

2 WHEREAS, The Legislature of the State of Texas is pleased to
3 recognize the General Motors Arlington Assembly Plant on the
4 occasion of its 50th anniversary, which will be celebrated in
5 January of 2004; and

6 WHEREAS, Since January of 1954, when the plant first
7 assembled the Pontiac Chieftain, it has produced a total of 7.5
8 million vehicles; and

9 WHEREAS, An innovative leader in the industry, the General
10 Motors Arlington Assembly Plant converted during the late 1990s
11 from assembling cars to assembling the 400 series pickup trucks and
12 such sports utility vehicles as the Chevrolet Suburban and the
13 Chevrolet Tahoe; it is the sole producer of the luxury sports
14 utility vehicle, the Cadillac Escalade; and

15 WHEREAS, By consistently upgrading its facilities, the plant
16 has always operated a state-of-the-art production site; a new
17 building for tire, wheel, and seat assembly was built in 1974; in
18 1988, it added a new building for a paint shop; and in 2000, a new
19 body shop building for the 800 series sports utility vehicles was
20 also added; and

21 WHEREAS, In tribute to its high standards of craftsmanship,
22 the assembly plant has been recognized with numerous awards,
23 including the Harbour Benchmark recognition for the full-size
24 sports utility vehicle; and

1 WHEREAS, The assembly plant employs 3,000 individuals,
2 contributes immeasurably to the local economy, and donates funds to
3 community activities; and

4 WHEREAS, The General Motors Arlington Assembly Plant is
5 highly regarded for its contributions to the prosperity and the
6 community life of the City of Arlington; now, therefore, be it

7 RESOLVED, That the 78th Legislature of the State of Texas,
8 3rd Called Session, hereby extend best wishes to all associated
9 with the plant as they prepare to celebrate its 50th anniversary;
10 and, be it further

11 RESOLVED, That a copy of this resolution be prepared for the
12 plant as an expression of esteem from the Texas Legislature.
