

AN ACT

relating to the general powers and authority of water districts.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 388.005(a), Health and Safety Code, is amended to read as follows:

(a) In this section, "political subdivision" means:

(1) an affected county; or

(2) any political subdivision in a nonattainment area or in an affected county other than:

(A) a school district; or

(B) a district as defined by Section 36.001 or 49.001, Water Code, that had a total annual electricity expense of less than \$200,000 in the previous fiscal year of the district [~~in a nonattainment area or in an affected county~~].

SECTION 2. Section 43.0751(a)(3), Local Government Code, is amended to read as follows:

(3) "Strategic partnership agreement" means a written agreement described by this section between a municipality and a district [~~that provides terms and conditions under which services will be provided and funded by the parties to the agreement and under which the district will continue to exist for an extended period of time if the land within the district is annexed for limited or full purposes by the municipality~~].

SECTION 3. Section 43.0751, Local Government Code, is

1 amended by amending Subsections (d), (f), and (i) and adding  
2 Subsection (q) to read as follows:

3 (d) Before the governing body of a municipality or a  
4 district adopts a strategic partnership agreement, it shall conduct  
5 two public hearings at which members of the public who wish to  
6 present testimony or evidence regarding the proposed agreement  
7 shall be given the opportunity to do so. Notice of public hearings  
8 conducted by the governing body of a municipality under this  
9 subsection shall be published in a newspaper of general circulation  
10 in the municipality and in the district. The notice must be in the  
11 format prescribed by Section 43.123(b) and must be published at  
12 least once on or after the 20th day before each date. Notice of  
13 public hearings conducted by the governing body of a district under  
14 this subsection shall be given in accordance with the district's  
15 notification procedures for other matters of public importance.  
16 Any notice of a public hearing conducted under this subsection  
17 shall contain a statement of the purpose of the hearing, the date,  
18 time, and place of the hearing, and the location where copies of the  
19 proposed agreement may be obtained prior to the hearing. The  
20 governing bodies of a municipality and a district may conduct joint  
21 public hearings under this subsection, provided that at least one  
22 public hearing is conducted within the district. [~~A municipality  
23 may combine the public hearings and notices required by this  
24 subsection with the public hearings and notices required by Section  
25 43.124.~~]

26 (f) A strategic partnership agreement may provide for the  
27 following:

1 (1) limited-purpose annexation of the district on  
2 terms acceptable to the municipality and the district [~~under the~~  
3 ~~provisions of Subchapter F~~] provided that the district shall  
4 continue in existence during the period of limited-purpose  
5 annexation;

6 (2) limited-purpose annexation of a district located  
7 in a county with a population of more than 3.3 million:

8 (A) only if the municipality does not require  
9 services, permits, or inspections or impose fees for services,  
10 permits, or inspections within the district; and

11 (B) provided that this subsection does not  
12 prevent the municipality from providing services within the  
13 district if:

14 (i) the provision of services is specified  
15 and agreed to in [~~such amendments to the timing requirements of~~  
16 ~~Sections 43.123(d)(2) and 43.127(b) as may be necessary or~~  
17 ~~convenient to effectuate the purposes of~~] the agreement;

18 (ii) the provision of services is not  
19 solely the result of a regulatory plan adopted by the municipality  
20 in connection with the limited-purpose annexation of the district;  
21 and

22 (iii) the district has obtained the  
23 authorization of the governmental entity currently providing the  
24 service;

25 (3) payments by the municipality to the district for  
26 services provided by the district;

27 (4) annexation of any commercial property in a

1 district for full purposes by the municipality, notwithstanding any  
2 other provision of this code or the Water Code, except for the  
3 obligation of the municipality to provide, directly or through  
4 agreement with other units of government, full provision of  
5 municipal services to annexed territory, in lieu of any annexation  
6 of residential property or payment of any fee on residential  
7 property in lieu of annexation of residential property in the  
8 district authorized by this subsection;

9 (5) a full-purpose annexation provision on terms  
10 acceptable to the municipality and the district [~~that specifies one~~  
11 ~~of the following:~~

12 [~~(A) the date on which the land included within~~  
13 ~~the district's boundaries shall be converted from the~~  
14 ~~municipality's limited-purpose jurisdiction to its full-purpose~~  
15 ~~jurisdiction, provided that such date shall not be later than 10~~  
16 ~~years after the effective date of the strategic partnership~~  
17 ~~agreement, or~~

18 [~~(B)(i) terms for payment of an annual fee to the~~  
19 ~~municipality by the district in lieu of full-purpose annexation,~~  
20 ~~the form in which each such payment must be tendered, a method of~~  
21 ~~calculating the fee, and the date by which each such payment must be~~  
22 ~~made, failure by a district to timely make an annual payment in lieu~~  
23 ~~of full-purpose annexation in the amount and form required by a~~  
24 ~~strategic partnership agreement shall be the only ground for~~  
25 ~~termination of the agreement with respect to annexation at the~~  
26 ~~option of the municipality,~~

27 [~~(ii) to determine a reasonable fee to be~~

1 ~~derived from residential property in a district, the municipality~~  
2 ~~or the district may request a cost-of-service study by an~~  
3 ~~independent third party agreeable to both parties if~~  
4 ~~cost-of-service data prepared by the municipality is not~~  
5 ~~acceptable. Both parties shall be equally responsible for the cost~~  
6 ~~of the study, which shall include an evaluation of the estimated~~  
7 ~~annual cost of providing municipal services to the residential~~  
8 ~~portion of the district over the next 10 years and the estimated~~  
9 ~~annual amount of ad valorem taxes from residential property the~~  
10 ~~municipality would receive on full-purpose annexation of the~~  
11 ~~district over the next 10 years. The fee shall not exceed the~~  
12 ~~estimated annual amount of residential ad valorem taxes that would~~  
13 ~~be derived by full-purpose annexation of the district, less the~~  
14 ~~estimated annual amount required to provide municipal services to~~  
15 ~~the residential property in the district if annexed for full~~  
16 ~~purposes. A fee determined through this methodology is subject to~~  
17 ~~renegotiation every 10 years at the request of either party to the~~  
18 ~~agreement following the same procedure used to set the fee in the~~  
19 ~~original agreement. This methodology does not apply to fees from~~  
20 ~~commercial property];~~

21 (6) conversion of the district to a limited district  
22 including some or all of the land included within the boundaries of  
23 the district, which conversion shall be effective on the  
24 full-purpose annexation conversion date established under  
25 Subdivision (5) [~~(5)~~(A)];

26 (7) agreements existing between districts and  
27 governmental bodies and private providers of municipal services in

1 existence on the date a municipality evidences its intention by  
 2 adopting a resolution to negotiate for a strategic partnership  
 3 agreement with the district shall be continued and provision made  
 4 for modifications to such existing agreements; and

5 (8) such other lawful terms that the parties consider  
 6 appropriate.

7 (i) A ~~[district that is negotiating for or that has adopted~~  
 8 ~~a] strategic partnership agreement may provide that the district~~  
 9 ~~shall not incur additional debt, liabilities, or obligations, to~~  
 10 ~~construct additional utility facilities, or sell or otherwise~~  
 11 ~~transfer property without prior approval of the municipality[~~  
 12 ~~which approval shall not be unreasonably withheld or delayed. An~~  
 13 ~~action taken in violation of this subsection is void].~~

14 (g) Subchapter F does not apply to a limited-purpose  
 15 annexation under a strategic partnership agreement.

16 SECTION 4. Section 43.123, Local Government Code, is  
 17 amended by adding Subsection (e) to read as follows:

18 (e) The deadline imposed by Subsection (d)(2) does not apply  
 19 to an area that:

20 (1) is owned by the United States, this state, or a  
 21 political subdivision of this state;

22 (2) is located outside the boundaries of a water  
 23 control and improvement district or a municipal utility district;  
 24 and

25 (3) is annexed for limited purposes in connection with  
 26 a strategic partnership agreement under Section 43.0751.

27 SECTION 5. Section 43.127(a), Local Government Code, is

1 amended to read as follows:

2 (a) Except as provided by Section 43.123(e), on [On] or  
3 before the date prescribed by the regulatory plan under Section  
4 43.123(d)(2), the municipality must annex the area for full  
5 purposes. This requirement may be waived and the date for  
6 full-purpose annexation postponed by written agreement between the  
7 municipality and a majority of the affected landowners. A written  
8 agreement to waive the municipality's obligation to annex the area  
9 for full purposes binds all future owners of land annexed for  
10 limited purposes pursuant to that waiver.

11 SECTION 6. Section 49.052, Water Code, is amended by adding  
12 Subsections (h) and (i) to read as follows:

13 (h) This subsection applies only to a district that is  
14 located wholly within the boundaries of a municipality with a  
15 population of more than 1.5 million, that is governed by Chapter  
16 375, Local Government Code, and that is governed by an appointed  
17 board consisting of nine or more members. Notwithstanding  
18 Subsection (f) or (g), a person is considered to have resigned from  
19 serving as a member of the board if the person fails to attend three  
20 consecutive meetings of the board. The remaining board members by  
21 majority vote may waive the resignation under this subsection if  
22 fairness requires that the absences be excused on the basis of  
23 illness or other good cause.

24 (i) Notwithstanding any other law, a director is eligible to  
25 serve on the board of a district governed by Chapter 375, Local  
26 Government Code, regardless of the municipality in which the  
27 director resides, if:

1           (1) the district is located within the boundaries of a  
2 municipality with a population of more than 1.8 million; and

3           (2) all or a part of the district is located more than  
4 five miles from the downtown city hall of that municipality.

5           SECTION 7. Section 49.067, Water Code, is amended to read as  
6 follows:

7           Sec. 49.067. CONTRACTS. (a) A district shall contract, and  
8 be contracted with, in the name of the district.

9           (b) Notwithstanding any other law, a contract for  
10 technical, scientific, legal, fiscal, or other professional  
11 services must be approved by the board unless specifically  
12 delegated by board action. The terms and conditions of such a  
13 contract, including the terms for payment, are subject to the  
14 decision of the board unless specifically delegated by board  
15 action. The board through such action cannot abrogate its fiscal  
16 responsibility.

17           SECTION 8. Section 49.068, Water Code, is amended to read as  
18 follows:

19           Sec. 49.068. CONTRACTS WITH GOVERNMENTAL AGENCIES. (a)  
20 The provisions of this chapter pertaining to bids and the Local  
21 Government Code notwithstanding, a district may purchase property  
22 from any governmental entity by negotiated contract without the  
23 necessity of securing appraisals or advertising for bids.

24           (b) The provisions of other law or a home-rule municipal  
25 charter notwithstanding, a municipality may contract with a  
26 district. The term of a contract under this subsection may be of  
27 unlimited duration.



1 SECTION 9. Section 49.103, Water Code, is amended by adding  
2 Subsection (h) to read as follows:

3 (h) If authorized by the board in the proceedings calling a  
4 director election, the secretary of the board or the secretary's  
5 designee, on receipt of the certification required by Section  
6 2.052(b), Election Code, shall post notice that the election is not  
7 to be held. The notice must be posted, on or before the  
8 commencement of early voting, at each polling place that would have  
9 been used in the election. If the notice is timely posted:

10 (1) the board or the board's designee is not required  
11 to:

12 (A) post or publish notice of the election;

13 (B) prepare or print ballots and election  
14 materials; or

15 (C) hold early and regular voting; and

16 (2) the board shall meet at the earliest practicable  
17 time to declare each unopposed candidate elected to office.

18 SECTION 10. Section 49.106(a), Water Code, is amended to  
19 read as follows:

20 (a) Before an election is held to authorize the issuance of  
21 bonds, other than refunding bonds, there shall be filed in the  
22 office of the district and open to inspection by the public an  
23 engineer's report covering the land, improvements, facilities,  
24 plants, equipment, and appliances to be purchased or constructed  
25 and their estimated cost, together with maps, plats, profiles, and  
26 data fully showing and explaining the report. The engineer's  
27 report is not:

1           (1) part of the proposition or propositions to be  
2 voted on; or

3           (2) a contract with the voters.

4           SECTION 11. Sections 49.153(a) and (e), Water Code, are  
5 amended to read as follows:

6           (a) The board, without the necessity of an election, may  
7 borrow money on negotiable or nonnegotiable notes of the district  
8 to be paid solely from the revenues derived from the ownership of  
9 all or any designated part of the district's works, plants,  
10 improvements, facilities, or equipment after deduction of the  
11 reasonable cost of maintaining and operating the facilities.

12           (e) Subsection (c) does not apply to:

13           (1) a note issued to and approved by the:

14                   (A) Farmers Home Administration;

15                   (B) United States Department of Agriculture;

16 [~~or~~]

17                   (C) Texas Water Development Board; or

18                   (D) North American Development Bank; or

19           (2) a district described by Section 49.181(h).

20           SECTION 12. Section 49.181(a), Water Code, is amended to  
21 read as follows:

22           (a) A district may not issue bonds unless the commission  
23 determines that the project to be financed by the bonds is feasible  
24 and issues an order approving the issuance of the bonds. This  
25 section does not apply to:

26           (1) refunding bonds if the commission issued an order  
27 approving the issuance of the bonds or notes that originally

1 financed the project;

2 (2) refunding bonds that are issued by a district  
3 under an agreement between the district and a municipality allowing  
4 the issuance of the district's bonds to refund bonds issued by the  
5 municipality to pay the cost of financing facilities; or

6 (3) bonds issued to and approved by the Farmers Home  
7 Administration, the United States Department of Agriculture, the  
8 North American Development Bank, or the Texas Water Development  
9 Board.

10 SECTION 13. Sections 49.183(a) and (b), Water Code, are  
11 amended to read as follows:

12 (a) Except for refunding bonds, or bonds sold to a state or  
13 federal agency or to the North American Development Bank, bonds  
14 issued by a district shall be sold after advertising for and  
15 receiving competitive sealed bids and shall be awarded to the  
16 bidder whose bid produces the lowest net effective interest rate to  
17 the district.

18 (b) Except for refunding bonds, or bonds sold to a state or  
19 federal agency or to the North American Development Bank, before  
20 any bonds are sold by a district, the board shall publish an  
21 appropriate notice of the sale:

22 (1) at least one time not less than 10 days before the  
23 date of sale in a newspaper of general circulation in the county or  
24 counties in which the district is located; and

25 (2) at least one time in one or more recognized  
26 financial publications of general circulation in the state as  
27 approved by the state attorney general.

1 SECTION 14. Section 49.194, Water Code, is amended by  
2 adding Subsection (g) to read as follows:

3 (g) A submission to the executive director required by this  
4 section may be made electronically.

5 SECTION 15. Subchapter H, Chapter. 49, Water Code, is  
6 amended by adding Section 49.2125 to read as follows:

7 Sec. 49.2125. FEES AND OTHER CHARGES OF CERTAIN REGIONAL  
8 WATER AUTHORITIES AFTER ANNEXATION. (a) This section applies to a  
9 regional water authority that:

10 (1) was established after January 1, 1999;

11 (2) is located entirely within a county with a  
12 population greater than 3.4 million according to the 2000 federal  
13 decennial census; and

14 (3) has a population greater than 375,000 according to  
15 the 2000 federal decennial census.

16 (b) Notwithstanding any other law, except to the extent an  
17 authority to which this section applies agrees in writing, a  
18 municipality's annexation of territory within the authority has no  
19 effect on the authority's ability to assess and collect inside the  
20 territory annexed by the municipality the types of fees, rates,  
21 charges, or special assessments that the authority was assessing  
22 and collecting at the time the municipality initiated the  
23 annexation; provided, however, that the authority's ability to  
24 assess and collect such fees, rates, charges, or special  
25 assessments shall terminate on the later to occur of (i) the date of  
26 final payment or defeasance of any bonds or other indebtedness,  
27 including any refunding bonds, that are secured by such fees,

1 rates, charges, or special assessments or (ii) the date that the  
2 authority no longer provides services inside the annexed territory.  
3 An authority to which this section applies shall continue to  
4 provide services to the annexed territory in accordance with  
5 contracts in effect at the time of the annexation unless a written  
6 agreement between the governing body of the authority and the  
7 governing body of the municipality provides otherwise.

8 SECTION 16. Sections 49.226(a), (c), and (d), Water Code,  
9 are amended to read as follows:

10 (a) Any personal property valued at more than \$300 or any  
11 land or interest in land owned by the district which is found by the  
12 board to be surplus and is not needed by the district may be sold  
13 under order of the board either by public or private sale, or the  
14 land, interest in land, or personal property may be exchanged for  
15 other land, interest in land, or personal property needed by the  
16 district. Except as provided in Subsection (b), land, interest in  
17 land, or personal property must be exchanged for like fair market  
18 value, which value may be determined by the district. In connection  
19 with the sale of surplus land, the board, at its discretion, may  
20 impose restrictions on the development and use of the land.

21 (c) Before [~~either~~] a public [~~or a private~~] sale of real  
22 property, the district shall give notice of the intent to sell by  
23 publishing notice once a week for two consecutive weeks in one or  
24 more newspapers with general circulation in the district.

25 (d) If the district has outstanding bonds secured by a  
26 pledge of tax revenues, the proceeds of the sale of property  
27 originally acquired with bond proceeds shall be:

1           (1) applied to retire outstanding bonds of the  
2 district; or

3           (2) held and treated as surplus bond proceeds and  
4 spent only as provided by the rules of the commission relating to  
5 surplus bond proceeds.

6           SECTION 17. Section 49.234(a), Water Code, as added by  
7 Section 15, Chapter 1423, Acts of the 77th Legislature, Regular  
8 Session, 2001, is amended to read as follows:

9           (a) A district or water supply corporation that operates a  
10 wastewater collection system to serve land within its boundaries by  
11 rule may prohibit the installation of private on-site wastewater  
12 holding or treatment facilities on land within the district that is  
13 not served by the district's or corporation's wastewater collection  
14 system. A district or corporation that has not received funding  
15 under Subchapter K, Chapter 17, may not require a property owner who  
16 has [~~already~~] installed an on-site wastewater holding or treatment  
17 facility before the adoption of the rule to connect to the  
18 district's or corporation's wastewater collection system.

19           SECTION 18. Subchapter H, Chapter 49, Water Code, is  
20 amended by adding Section 49.236 to read as follows:

21           Sec. 49.236. NOTICE OF TAX HEARING. (a) Before the board  
22 adopts an ad valorem tax rate for the district for debt service,  
23 operation and maintenance purposes, or contract purposes, the board  
24 shall give notice of each meeting of the board at which the adoption  
25 of a tax rate will be considered. The notice must:

26           (1) contain a statement in substantially the following  
27 form:

"NOTICE OF PUBLIC HEARING ON TAX RATE

"The (name of the district) will hold a public hearing on a proposed tax rate for the tax year (year of tax levy) on (date and time) at (meeting place). Your individual taxes may increase or decrease, depending on the change in the taxable value of your property in relation to the change in taxable value of all other property and the tax rate that is adopted."; and

(2) . contain the following information:

(A) the district's total adopted tax rate for the preceding year and the proposed tax rate, expressed as an amount per \$100;

(B) the difference, expressed as an amount per \$100 and as a percent increase or decrease, as applicable, in the proposed tax rate compared to the adopted tax rate for the preceding year;

(C) the average appraised value of a residence homestead in the district in the preceding year and in the current year; the district's total homestead exemption, other than an exemption available only to disabled persons or persons 65 years of age or older, applicable to that appraised value in each of those years; and the average taxable value of a residence homestead in the district in each of those years, disregarding any homestead exemption available only to disabled persons or persons 65 years of age or older;

(D) the amount of tax that would have been imposed by the district in the preceding year on a residence homestead appraised at the average appraised value of a residence

1 homestead in that year, disregarding any homestead exemption  
2 available only to disabled persons or persons 65 years of age or  
3 older;

4 (E) the amount of tax that would be imposed by the  
5 district in the current year on a residence homestead appraised at  
6 the average appraised value of a residence homestead in that year,  
7 disregarding any homestead exemption available only to disabled  
8 persons or persons 65 years of age or older, if the proposed tax  
9 rate is adopted; and

10 (F) the difference between the amounts of tax  
11 calculated under Paragraphs (D) and (E), expressed in dollars and  
12 cents and described as the annual increase or decrease, as  
13 applicable, in the tax to be imposed by the district on the average  
14 residence homestead in the district in the current year if the  
15 proposed tax rate is adopted.

16 (b) Notice of the hearing shall be:

17 (1) published at least once in a newspaper having  
18 general circulation in the district at least seven days before the  
19 date of the hearing; or

20 (2) mailed to each owner of taxable property in the  
21 district, at the address for notice shown on the most recently  
22 certified tax roll of the district, at least 10 days before the date  
23 of the hearing.

24 SECTION 19. Section 49.271, Water Code, is amended by  
25 adding Subsection (e) to read as follows:

26 (e) A district contract for construction work may include  
27 economic incentives for early completion of the work or economic



1 disincentives for late completion of the work.

2 SECTION 20. Section 49.273, Water Code, is amended by  
3 adding Subsection (1) to read as follows:

4 (1) The board is not required to advertise or seek  
5 competitive bids for security or surveillance systems or components  
6 of or additions to district facilities relating to security or  
7 surveillance, including systems used for the prevention of  
8 terrorist or criminal acts and incidents or acts of war, if the  
9 board finds that doing so would compromise the safety and security  
10 of district facilities or residents.

11 SECTION 21. Section 49.278(a), Water Code, is amended to  
12 read as follows:

13 (a) This subchapter does not apply to:

14 (1) equipment, materials, or machinery purchased by  
15 the district at an auction that is open to the public;

16 (2) contracts for personal or professional services or  
17 for a utility service operator;

18 (3) contracts made by a district engaged in the  
19 distribution and sale of electric energy to the public;

20 (4) contracts for services or property for which there  
21 is only one source or for which it is otherwise impracticable to  
22 obtain competition; ~~[or]~~

23 (5) high technology procurements; or

24 (6) contracts for the purchase of electricity for use  
25 by the district.

26 SECTION 22. Section 49.303, Water Code, is amended to read  
27 as follows:

1           Sec. 49.303. EXCLUDING LAND OR OTHER PROPERTY FROM  
2 DISTRICT. (a) A district may exclude land or other property from  
3 the district under this subchapter if the district has no  
4 outstanding bonds payable in whole or in part from taxes.

5           (b) If a district has no outstanding [~~Before a district~~  
6 ~~orders an election for the authorization of~~] bonds payable in whole  
7 or in part from taxes, the board may, on its own motion, call a  
8 hearing on the question of the exclusion of land or other property  
9 from the district under the provisions of this subchapter [~~section~~  
10 ~~and Sections 49.304 through 49.307~~], if the exclusions are  
11 practicable, just, or desirable.

12           [~~(b) The board must call a hearing on the exclusion of land~~  
13 ~~or other property from the district on the written petition of any~~  
14 ~~landowner or property owner in the district filed with the~~  
15 ~~secretary of the board before the first election on the question of~~  
16 ~~whether bonds should be issued payable in whole or in part from~~  
17 ~~taxes is ordered.~~]

18           (c) If a district has no outstanding bonds payable in whole  
19 or in part from taxes, the [~~The~~] board may hold a hearing on the  
20 exclusion of land or other property from the district [~~if the~~  
21 ~~district has not issued bonds payable in whole or in part from~~  
22 ~~taxes, and~~] if a landowner or property owner submits a signed  
23 petition to the secretary of the board evidencing the consent of the  
24 owners of a majority of the acreage proposed to be excluded and a  
25 majority of the taxable property in the district, as reflected by  
26 the most recent certified tax roll of the district.

27           (d) A district that has previously held an election at which

1 approval was given for the issuance of bonds payable in whole or in  
2 part from taxes may not rely on that election for the issuance of  
3 the bonds if after the bond election, but before the bonds are  
4 issued, land or other property is excluded from the district as  
5 provided by this subchapter. The board must call and hold another  
6 bond election and receive voter approval [~~as provided by this~~  
7 ~~subchapter~~] before issuing those bonds.

8 (e) A district may not exclude land or other property from  
9 the district under this section if the district has issued bonds  
10 payable in whole or in part from taxes and those bonds are  
11 outstanding.

12 SECTION 23. Section 49.304(a), Water Code, is amended to  
13 read as follows:

14 (a) If the board determines that an exclusion hearing should  
15 be held as provided by Section 49.303 [~~(a) or (c), or if a written~~  
16 ~~petition requesting an exclusion hearing is filed with the~~  
17 ~~secretary of the board as provided by Section 49.303(b)] , the board  
18 shall give notice of the time and place of a hearing to announce its  
19 own conclusions relating to land or other property to be excluded  
20 and to receive petitions for exclusion of land or other property.~~

21 SECTION 24. Sections 49.351(a), (k), and (l), Water Code,  
22 are amended to read as follows:

23 (a) A district providing potable water or sewer service to

15 benefits if it finds that the aggregate amount of assessed benefits  
16 as shown by the previous final judgment and decree is insufficient  
17 to carry out the original engineer's report [~~plan of reclamation~~]  
18 or changes, repairs, or additions to the report [~~plan~~] or there has  
19 been a material change in the relative value of the benefits  
20 conferred on the property in the district, or for some reason the  
21 assessment of benefits is inadequate or inequitable.

22 SECTION 55. Section 57.275(d), Water Code, is amended to  
23 read as follows:

24 (d) If the engineer's report [~~plan of reclamation~~] is  
25 modified, or if extensive repairs or additions are made, the  
26 provisions of this section apply to districts that levy taxes on the  
27 ad valorem basis, but the commissioners of appraisal shall

1 assess only the damages which will accrue to the property inside or  
2 outside the district as a result of the changes in the report  
3 [~~plan~~].

4 SECTION 56. Section 67.010(d), Water Code, is amended to  
5 read as follows:

6 (d) A political subdivision may contract with a corporation  
7 under Section 402.014, Local Government Code, to carry out this  
8 chapter. If a corporation issues bonds secured by a contract  
9 entered into under Section 402.014, Local Government Code, the  
10 corporation is considered to be acting for or on behalf of that  
11 political subdivision for the purposes of Section 1201.002(1),  
12 Government Code. A political subdivision is authorized to approve  
13 by ordinance, resolution, or order the articles of incorporation  
14 and the bylaws of a corporation that is created for the purpose of  
15 constructing facilities under a contract as provided by Section  
16 402.014, Local Government Code.

17 SECTION 57. The following provisions are repealed:

18 (1) Sections 54.0163(e), 54.508, 57.094, 57.108(a),  
19 57.154(b), and 57.156, Water Code;

20 (2) Section 402.908, Local Government Code; and

21 (3) Subchapter C, Chapter 441, Transportation Code.

22 SECTION 58. (a) Except as provided by this section, a  
23 provision of a strategic partnership agreement entered into before  
24 December 31, 2003, that does not comply with Section 43.0751(f)(2),  
25 Local Government Code, as amended by this Act, is not enforceable  
26 after December 31, 2003, to the extent of the noncompliance.

27 (b) A permit issued before December 31, 2003, by a

1 municipality with a population of 1.9 million or more remains valid  
2 until its expiration and shall be recognized by the county.

3 (c) A municipality with a population of 1.9 million or more  
4 may not enforce, under a strategic partnership agreement, a code  
5 provision that would otherwise require a building permit from the  
6 municipality after the effective date of this Act.

7 (d) This section does not affect the validity or  
8 enforceability of a provision of a strategic partnership agreement  
9 that requires services or imposes fees if the services or fees  
10 relate to emergency services that were specifically requested by  
11 the board of a municipal utility district or if the services or fees  
12 have been approved by a state agency or a political subdivision that  
13 is not a party to the strategic partnership agreement.

14 SECTION 59. (a) Section 43.127(a), Local Government Code,  
15 as amended by this Act, applies to an area described by Section  
16 43.123(e), Local Government Code, as added by this Act, that is  
17 annexed for limited purposes in connection with a strategic  
18 partnership agreement before, on, or after September 1, 2003.


19 (b) For the 2003 tax year, the change in law made by Section  
20 49.236, Water Code, applies only to a conservation and reclamation  
21 district created under Section 52, Article III, or Section 59,  
22 Article XVI, Texas Constitution, and governed by Chapter 49, Water  
23 Code, that adopts its tax rate on or after September 1, 2003. For  
24 the 2003 tax year, a district that adopts its tax rate before  
25 September 1, 2003, is governed by the law as it existed prior to the  
26 effective date of this Act, and that law is continued in effect for  
27 that purpose.

1           SECTION 60. This Act takes effect immediately if it  
2 receives a vote of two-thirds of all the members elected to each  
3 house, as provided by Section 39, Article III, Texas Constitution.  
4 If this Act does not receive the vote necessary for immediate  
5 effect, this Act takes effect September 1, 2003.








