

1 AN ACT

2 relating to the powers and duties of the Montgomery County  
3 Municipal Utility District No. 112.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Subtitle F, Title 6, Special District Local Laws  
6 Code, is amended by adding Chapter 8370 to read as follows:

7 CHAPTER 8370. MONTGOMERY COUNTY MUNICIPAL UTILITY DISTRICT NO. 112

8 SUBCHAPTER A. GENERAL PROVISIONS

9 Sec. 8370.001. DEFINITION. In this chapter, "district"  
10 means the Montgomery County Municipal Utility District No. 112.

11 [Sections 8370.002-8370.100 reserved for expansion]

12 SUBCHAPTER B. POWERS AND DUTIES

13 Sec. 8370.101. MUNICIPAL UTILITY DISTRICT POWERS AND  
14 DUTIES. The district has the powers and duties provided by the  
15 general law of this state, including Chapters 49 and 54, Water Code,  
16 applicable to municipal utility districts created under Section 59,  
17 Article XVI, Texas Constitution.

18 Sec. 8370.102. NO ALLOCATION AGREEMENT. Section 54.016(f),  
19 Water Code, does not apply to the district.

20 SECTION 2. (a) The legal notice of the intention to  
21 introduce this Act, setting forth the general substance of this  
22 Act, has been published as provided by law, and the notice and a  
23 copy of this Act have been furnished to all persons, agencies,  
24 officials, or entities to which they are required to be furnished

1 under Section 59, Article XVI, Texas Constitution, and Chapter 313,  
2 Government Code.

3 (b) The governor, one of the required recipients, has  
4 submitted the notice and Act to the Texas Commission on  
5 Environmental Quality.

6 (c) The Texas Commission on Environmental Quality has filed  
7 its recommendations relating to this Act with the governor, the  
8 lieutenant governor, and the speaker of the house of  
9 representatives within the required time.

10 (d) All requirements of the constitution and laws of this  
11 state and the rules and procedures of the legislature with respect  
12 to the notice, introduction, and passage of this Act are fulfilled  
13 and accomplished.

14 SECTION 3. This Act takes effect September 1, 2011.
