- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 28.025, Education Code, is amended by
- 7 amending Subsection (b-1) and adding Subsection (b-11) to read as
- 8 follows:
- 9 (b-1) The State Board of Education by rule shall require
- 10 that:
- 11 (1) except as provided by Subsection (b-2), the
- 12 curriculum requirements for the recommended and advanced high
- 13 school programs under Subsection (a) include a requirement that
- 14 students successfully complete:
- 15 (A) four credits in each subject of the
- 16 foundation curriculum under Section 28.002(a)(1), including at
- 17 least one-half credit in government and at least one-half credit in
- 18 economics to meet the social studies requirement;
- 19 (B) for the recommended high school program, two
- 20 credits in the same language in a language other than English under
- 21 Section 28.002(a)(2)(A) and, for the advanced high school program,
- 22 three credits in the same language in a language other than English
- 23 under Section 28.002(a)(2)(A); and
- 24 (C) for the recommended high school program, six

- 1 elective credits and, for the advanced high school program, five
- 2 elective credits;
- 3 (2) one or more credits offered in the required
- 4 curriculum for the recommended and advanced high school programs
- 5 include a research writing component; and
- 6 (3) the curriculum requirements for the minimum,
- 7 recommended, and advanced high school programs under Subsection (a)
- 8 include a requirement that students successfully complete:
- 9 (A) one credit in fine arts under Section
- 10 28.002(a)(2)(D); and
- 11 (B) except as provided by Subsection (b-11), one
- 12 credit in physical education under Section 28.002(a)(2)(C).
- 13 (b-11) In adopting rules under Subsection (b-1), the State
- 14 Board of Education shall allow a student who is unable to
- 15 participate in physical activity due to disability or illness to
- 16 substitute one credit in English language arts, mathematics,
- 17 science, or social studies or one academic elective credit for the
- 18 physical education credit required under Subsection (b-1)(3)(B). A
- 19 credit allowed to be substituted under this subsection may not also
- 20 be used by the student to satisfy a graduation requirement other
- 21 than completion of the physical education credit. The rules must
- 22 provide that the determination regarding a student's ability to
- 23 participate in physical activity will be made by:
- 24 (1) if the student receives special education services
- 25 under Subchapter A, Chapter 29, the student's admission, review,
- 26 and dismissal committee;

- 1 services under Subchapter A, Chapter 29, but is covered by Section
- 2 504, Rehabilitation Act of 1973 (29 U.S.C. Section 794), the
- 3 committee established for the student under that Act; or
- 4 (3) if each of the committees described by
- 5 Subdivisions (1) and (2) is inapplicable, a committee established
- 6 by the school district of persons with appropriate knowledge
- 7 regarding the student.
- 8 SECTION 2. This Act takes effect immediately if it receives
- 9 a vote of two-thirds of all the members elected to each house, as
- 10 provided by Section 39, Article III, Texas Constitution. If this
- 11 Act does not receive the vote necessary for immediate effect, this
- 12 Act takes effect September 1, 2011.
